The **Chair of Internet and Telecommunications Business** (Professor Jan Krämer) at the **University of Passau** invites applications for the position of

Postdoctoral Researcher (m/f/d) (full-time 100%)

to start at the earliest convenience.

This is a **fully-funded full-time position**, based on a fixed-term contract valid for a period of three years, with the option of renewal. Remuneration is in accordance with pay grade E13 of the German public-sector collective agreement, TV-L; the salary step depends on your qualifications and experience. Minimum annual salary is currently at 59,189 €.

The position is financed by a third-party funded interdisciplinary project on "Resilient Regulation in Digital Markets", and the successful candidate will devote part of their time to developing and working on experimental studies related to the project, in particular on standard setting processes in digital industries, e.g. for mobile applications. Further, the candidate will contribute to the coordination of the project and dissemination of its results.

What we seek

- You have a Ph.D. degree in economics, information systems or a related field of study or are expected to obtain your degree soon.
- Very good analytical skills and most importantly a keen interest in experimental economics and the economics of digital markets and the digital economy.
- Ability to work in a multi-disciplinary team, open-mindedness, and the motivation to work on a research project independently and diligently.
- Excellent spoken and written English language skills. Knowledge of German is not a requirement.

What we offer

- The position is a fixed-term appointment for three years, with a possibility of extension pending successful evaluation. The starting date for the appointment can be set upon mutual agreement, but should be no later than 1st April 2024. A conversion to an indefinite position (tenured) is not possible.
- Become part of a particularly strong research team with internationally recognised research activities at the highest scholarly level (see www.ibusiness.uni-passau.de/en).
- The chair is involved in several large-scale research projects with national and international partners and regularly hosts leading international scholars.
- Dedicated supervision and mentorship with a proven track-record. This has resulted in publications in leading academic journals, such as Management Science, Information Systems Research and Management Information Systems Quarterly. Previous postdoctoral researchers have advanced to assistant and full professorships in Information Systems.
- Inclusion in the vibrant interdisciplinary and international community of the Research
 Training Group 2720 Digital Platform Ecosystems (see https://dpe.uni-passau.de/en for details) funded by the German Research Foundation (DFG).
- Own research budget for conference visits and hiring student workers to assist with research.
- **No formal teaching obligation**, but possibility to participate in and contribute to the Chair's teaching portfolio.
- You will participate regularly in international conferences, become integrated into an
 international research network and contribute to the national and international political
 discourse on the regulation of the digital economy.
